


Global Food Security Index (GFSI) 2022

The Philippines ranked 67th out of 113 countries in the 2022 edition of the Global Food Security Index (GFSI) based on the four pillars of food security:

- Food affordability;
- Availability;
- Quality and safety; and
- Sustainability and adaption.

Among the countries in the Asia-Pacific region, the country ranked 13th out of 23 countries.



About 42 million Filipinos (33.4%) with moderate food insecurity (2021)

5.3 million Filipinos (2%) with severe food insecurity (2021)

75.2 million Filipinos cannot afford a healthy diet in 2020

Food Balance Sheets (FBS) of the Philippines

An annual publication of the Philippine Statistics Authority aimed at presenting a comprehensive picture of the country's food supply.

National Nutrition Survey (NNS)

A comprehensive survey conducted by the DOST-FNRI that covers components such as anthropometry, biochemical, clinical and health, dietary, socioeconomic, food insecurity, government program participation, infant and young child feeding, and maternal health and nutritional status.




Global Food Security Index (GFSI)


Conducted annually by the Economist Impact, the GFSI is the pre-eminent source of intelligence on the drivers of global food security across 113 countries. The index is a dynamic quantitative and qualitative benchmarking model constructed from 68 unique indicators on food affordability, availability, quality and safety, and sustainability and adaptation.

Medium-Term Plans with Nutrition Lens








